Legislation requires an update by July 1 2025 to include the proposed levels of service for all asset categories and a financial Strategy defining how to fund the proposed services.

The following licenses were issued in December 2024.

Annually the following licences were issued:

- New Business License 5
- Short Term Rental License 12
- Business License Renewals 81

In 2024 there were 5 vested properties added to the land inventory

Annual cash flow generated through external collections was \$4,355.28.

Charity rebates were issued - \$10,791.46

There are no concerns with accounts receivable. The amount is consistent, with most outstanding accounts falling in the current 30-day period.
